# **Overview**

**Lincolnshire Music Service** is excited to announce the launch of the **Lincolnshire Local Cultural Education Partnership** supported by *Arts Council England*. Evidence shows that access to creative opportunities can make a massive difference to young people's development, but there are often a huge range of barriers that prevent young people from gaining those experiences, especially in large rural areas like ours.







The aim of this new project is to improve access to cultural education opportunities for young people in some of the most rural parts of our county, by working with a range of partners to find new ways of developing and delivering creative learning.

Through previous pilot projects that have taken place over recent years (see below), **LincoInshire Music Service** has established a unique partnership model working with local schools, creative professionals, teachers and specifically with LincoInshire's own **Rhubarb Theatre**. This *new* programme will deliver a 2-year creative partnership across the county that will focus on young people's sense of place and aim to be transformational. Working initially with 20 rural primary schools who support some of our most vulnerable communities, the aim will be to establish, deliver and drive a step change in offering creative & cultural opportunities for young people. We will also work with existing networks to add value and identify areas for development and growth across the county.

There will be three strands of delivery:

#### 1. Education

The Lincolnshire LCEP will work with 20 identified rural schools to spotlight local talent, deliver workshops to unleash creative potential and enliven a passion and knowledge for the arts.

#### 2. Collaboration

Micro-investments for emerging collaborations between schools and the creative sector driven by evidenced need.

#### 3. Development

Develop relevant, ambitious creative/cultural practice and offers with and for local people and their communities

## **Background & Further Information**

### What are Local Cultural Education Partnerships?

The idea for LCEPs was developed in partnership with the Department for Education (DfE) in 2015, with the aim of improving the alignment of cultural education of young people. Pilot LCEPs were launched in Great Yarmouth, Bristol, and Barking & Dagenham. Since then, the success of these partnerships has inspired the emergence of 140 LCEPs across England.

The details of how each of these 140 LCEPs is designed and delivered is determined entirely by the local partners who have taken the project on - there is no set route for creating an LCEP and consequently they are all different.

# What is the journey that led to the formation of the Lincolnshire Local Cultural Education Partnership?

It has taken quite a bit of time to find the right way to develop an LCEP for Lincolnshire. This is the timetable of all of the projects that have taken place in the last 8 years that have led to this point: -

## Have the delivery partners already been selected?

Yes, the 20 rural schools and our main delivery partner, Rhubarb Theatre, that supported the original submission to Arts Council England, are all signed up.

Lincolnshire Music Service is also working with the *KYRA Teaching Alliance* as a principal conduit for the identified schools and also with *Simon Hollingworth*, a local Creative Producer, who is acting as the project mentor.

## How were the partners selected?







Each of the selected schools were identified based on a number of factors including:

- Rurality (including isolation)
- Low Number of Pupils on Roll
- Free School Meal / Pupil Premium %
- School Priorities
- High Number of SEND Pupils

Rhubarb Theatre was approached to support the pilot phase of the project in 2023/2024 which proved to be very successful and the partnership was consequently developed further into the Lincolnshire LCEP proposal to ACE. The KYRA Teaching Alliance already works closely with the Music Service and was well placed to advise on identifying relevant rural schools and Simon Hollingworth is a well-established Producer who has a background in arts education.

### Is there a cost for the identified schools to participate?

Yes, each school is contributing £150 to the programme.

## Will there be opportunities for other schools and partners to get involved?

Yes, we have some additional funding available for hyper-local activities, networks and CPD opportunities which will be disseminated further in due course. This funding is limited though and will be distributed on a case-by-case basis. We will also be looking for schools and creative partners to join our Advisory Committee to support the development of the Lincolnshire LCEP.

#### Will there be future opportunities for a further round of activities?

Hopefully yes, however this will be subject to Lincolnshire Music Service securing further funding.

#### How will the Lincolnshire LCEP be managed?

Two part-time freelance staff will be recruited in the coming weeks to manage the Lincolnshire LCEP, a *Project Producer* and an *Assistant Project Producer*.

They will report to Jennifer Mckie, the Head of the Lincolnshire Music Service and the activities of the Lincolnshire LCEP will be steered by an Advisory Committee, the members of which will also be recruited in the coming months.

### **Role of Project Producer**

The Project Producer will support LLCEP by:

- Providing the administrative support to implement and develop the LLCEP in line with our recently successful Arts Council England project application.
- Overseeing the LLCEP budget, monitoring income and expenditure in line with the proposed projections.
- Coordinating the LLCEP schools' delivery arm with a planned outreach programme to 20 confirmed schools in partnership with Rhubarb Theatre.
- Managing and building relationships with the local cultural and creative sector leading to networks (including adding value to existing infrastructures) as well identifying additional outreach opportunities through micro-investments by the LLCEP.
- Supporting the recruitment and line management of the Assistant Project Producer role (March 2025- July 2026)
- Recruiting and engaging with new LLCEP partners including educational settings, creative
  practitioners and organisations, health and wellbeing professionals, children and young
  people who represent the demographic of Lincolnshire.
- Co-ordinating digital and social media presence; establishing and increasing followers to social online platforms and updating the LLCEP page within the LMS website (<u>Lincolnshire</u> Cultural Education Partnership | LMS (Incsmusicservice.org)).
- Providing administration support in the creation of a marketing and communications plan.
- Creating and distributing a quarterly e-newsletter.
- Planning and delivering events/activities for LLCEP to support and widen the reach and build awareness. Please note there is a separate budget for micro-investments and networking.
- Co-ordinating, forming and administration of a LLCEP Steering Group and any subsequent Task and Finish meetings including minute taking, arranging venues, invites and catering.
- Acting as a point of contact for all partners.
- Identifying and applying for funding and investment to fund LLCEP activity, programmes, and the role post July 2026 with support from LLCEP Partners and LMS.
- Actively networking with local, regional and national Cultural education Partnerships to learn from best practice and raise the profile of LLCEP.
- To undertake any other administrative duties set by the head of Lincolnshire Music Service and Lincolnshire Music Education Hub Strategic Group.

The post holder will manage their own workload, priorities and deliver project administration effectively. It is essential that they are ICT literate and are self-sufficient in office administration.

- Passion and interest in engaging children and young people of Lincolnshire

- Experience of working with educational institutions
- Working knowledge of Lincolnshire

- The Project Producer will be freelance and will be responsible for their own tax and national insurance contributions.
